We're excited finally to meet in person experts, researchers, innovators, policy makers, associations, and passionate people about food safety to discuss together and shape the Food Safety System of the future!

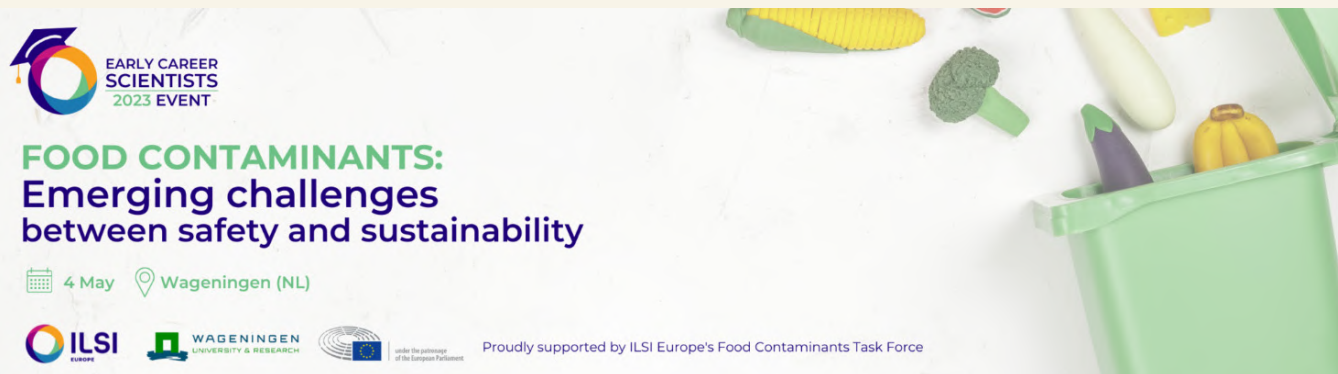
*The EU Food Safety Forum will be held in **Brussels on 28-29 November at La Tricoterie**, in a dynamic networking framework!*

EFSA has reviewed its guidance document on the risk assessment of plant protection products and bees (*Apis mellifera*, *Bombus* spp. and solitary bees), which was originally published in 2013 but never endorsed unanimously by Member State representatives on the European Commission's Standing Committee for Plants, Animals, Food and Feed.

Pesticide Residue Intake Model (PRIMo) revision 4

EFSA's Methodology and Scientific Support (MESE) Unit has launched a public consultation on the 4th revision of the Pesticide Residue Intake Model (PRIMo).

In the safety assessments of EU maximum residues levels (MRLs) for pesticides, or proposals for MRLs, the chronic and acute dietary consumer exposure to pesticide residues is estimated by using a calculation model developed by EFSA (Pesticide Residue Intake Model – PRIMo). EFSA is currently developing revision 4 of the model, which will be a new web-based tool, as opposed to the current Excel-based spreadsheets.

Interested parties are invited to submit their comments on the tool and on the accompanying technical report (see below) by the 30/06/2023.

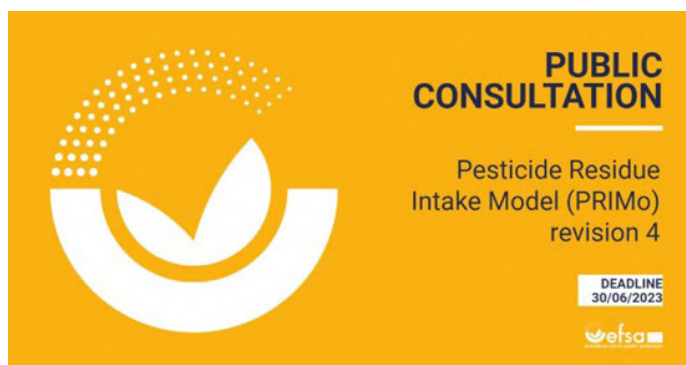

EIT Food supports healthy and sustainable food systems through its Youth Mission programme

In 2022, EIT Food launched its food education programme called Youth Mission, an umbrella initiative to promote healthy and sustainable food choices among young people, and to support them in becoming future agrifood leaders. The Youth Mission is gaining new insights into how to deepen learning experiences around food, promote health and sustainability, and motivate future generations to pursue careers in the agri-food sector. This year, EIT Food launched phase two of the Youth Mission. The lesson plans will be piloted in three more countries: Poland, Turkey, and the United Kingdom. Additional educational materials will be developed, such as a resource package for events. Youth Mission's focus will be on researching, synthesising, enhancing and testing existing materials. With a strong communication strategy, the goal is to establish the Youth Mission as the place to go to find quality resources for food education, ensuring the project has a lasting impact.

The Conference is organized by WUR [Law Group](#) on the 25th and 26th May at Wageningen University & Research. "The Future of Food Law" conference reflects on EU food law beyond the Farm to Fork Strategy. By the end of 2023, the proposal of the European Commission's Framework for a Sustainable Food System will be published, marking the end of the Farm to Fork Strategy policy process.

The conference will be organized by Prof. Dr. Madeleine Plötz, director of the Institute of Food Quality and Food Safety, University of Veterinary Medicine Hannover, Foundation, in cooperation with the Society for Mycotoxin Research. The Mycotoxin Workshop is one of the oldest mycotoxin meetings worldwide. It originates from small meetings of mycotoxin researchers in Germany starting already in 1979 and has now been established as an annual European meeting since 1997, covering all aspects of mycotoxin research.
